Explanation of the appropriateness of the assessment methods in assessing the intended learning outcomes:

Students' active participation in lectures, tutorial discussions and online Blackboard learning is essential in ensuring students' understanding and improving presentation skills.

Oral presentations or group projects scheduled in tutorial sessions can best assess the students' overall grasp of the knowledge and skills learnt.

The term paper should be written in Chinese and the word count is 2,000 - 3,000, finalized in accordance with the instructor's comments and feedbacks, will best assess the students' command of the knowledge and skills learnt from the subject and their ability to present specific aspects of the subject. (The mid-term draft of the term paper can fulfil the CW requirement)

Students will be arranged in groups and led by course instructor to do fieldwork in Hong Kong or Mainland China. They will visit archeological sites, museums, temples etc. related to tangible and intangible cultural heritage in order to enhance their learning experience and deepen their understanding of Chinese cultural heritage in realworld and up-to-date situations. An assignment will be given to students to explore the real situation of the site(s).

Students must obtain a D or above on the Writing Requirement assignment to pass the subject
