<b>Subject Title</b>	Cultural History of the Eastern Silk Road 絲綢之路東段文化簡史

<b>Objectives</b>	This subject introduces key features of the cultural history of the eastern portion of The Silk Road across the Han and Tang Dynasties to highlight imperial China's interaction with and influence on its neighboring countries. With exploration of the cities along the Silk Road, students will be guided to see the transformation the Silk Road throughout early and medieval China. Issues and themes from history, religion, ritual, hierarchy, art, architecture, archaeology, culture, music and dance, will be addressed for an understanding of cosmopolitanism and cultural life in imperial China.

Increase global awareness through examining critically crucial issues related to the cultural interactions on the Silk Road from the Han dynasty until the present day.</li> </ul>
